Entries are deemed to be received at the time of receipt by Promoter (Basketball Victoria) and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
3. Valid and eligible entries will be accepted during the Promotional Period.

 - a. The four Bulla Local Heroes winners will be determined by representatives of the Promoter, with the overall winner from those four entrants to be selected via public vote on the Basketball Victoria Facebook page and Basketball Victoria Instagram page.
 - i. The best valid entries, as determined by the judges, will win the prizes specified in the Schedule above.
 - ii. The judges may select additional reserve entries which they determine to be the next best, and record them in order, in case of an invalid entry or ineligible entrant.
 - iii. The winner will be determined by skill and hard work. Chance plays no part in determining the winner. The judges' decision is final, and binding and no correspondence will be entered.
6. All reasonable attempts will be made to contact each winner.
7. If any winner chooses not to take their prize (or is unable to), or does not take or claim a prize by the time specified by the Promoter, or is unavailable, they forfeit the prize and the Promoter is not obliged to substitute the prize.

In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered.
